Permits

Local authorities already issue a number of permits or registrations for activities under existing gambling legislation. Under the Gambling Act 2005, the Licensing Authority will be responsible for dealing with the following permits and registrations:

- Unlicensed Family Entertainment Centre Gaming Machine Permits
- Registration of small lottery licences
- Club Gaming Permits
- Club Gaming Machine Permits
- Licensed Premises Gaming machine Permits
- Prize Gaming Permits

Unlike premises licence fees, the Government prescribes permit fees and therefore licensing authorities have no discretion in this matter. The tables below show the fee structure for the various permits.
