



Tackling Child Sexual Abuse – FREE Training Offer

In 2018/19 the Local Safeguarding Children Boards ran a campaign to enhance multi agency responses to child sexual abuse (CSA).

A key objective of the campaign was to provide the multi-agency workforce with the knowledge, skills and confidence to support children and families who are impacted by child sexual abuse. Funding provided by the Dorset Police and Crime Commissioner facilitated the provision of CSA specific training to address the identified training needs. A further round of training has been scheduled and Acts Fast (a local organisation experienced with working with families affected by CSA) will be delivering an additional 6 sessions on the units below.

Unit A: *To enable delegates to understand the **impact of trauma** on children, young people and families within a CSA context*

Unit C: *To enable delegates to improve their **understanding of the legal pathway** (both criminal and family law) in the context of CSA and implications for children and families support needs.*
