**Subject:** Extending the Dorset Heathlands Planning Framework Supplementary Planning Document (SPD) 2014 until replaced by the revised Dorset Heathland Supplementary Planning Document 2015.

**Decision taken:** To extend the Dorset Heathlands Planning Framework Supplementary Planning Document (SPD) 2014 until replaced by the revised Dorset Heathland Supplementary Planning Document 2015.

**Reasons for the decision:** The current SPD was adopted in 2012 with an end date of April 2014, it was subsequently rolled on by way of cabinet member decision until the end of 2014. A revised SPD is presently being consulted upon that will align with the Community Infrastructure Levy legislation. Prior to the adoption of the revised Heathland SPD, and to enable developers to continue to satisfy the requirements of the Habitats Regulations, there is a need to roll forward existing SPD.

**Call-in and Urgency:** the decision is subject to the Council's call-in procedure

**Background:** The Dorset Heathlands Planning Framework Supplementary Planning Document (SPD) was adopted by all of the South East Dorset Authorities in 2012 (by Bournemouth Borough Council in September 2012) with an end date of April 2014. It was subsequently rolled on by way of cabinet member decision until December 2014. The SPD superseded its forerunner, the Dorset Heathlands Interim Planning Framework of 2007 and subsequent revisions.

The SPD provides the overall approach to avoiding and/or mitigating the adverse effects of urban pressure on the Dorset Heathlands International Sites that result from the grant of planning permission, including setting a regime for taking contributions from development. The SPD supplements the adopted Core Strategy Policy CS 33 'Heathland'.

The Local Authorities are currently consulting on a replacement SPD which will align with CIL requirements. It is planned to adopt this by April 2015. Rather than create a guidance vacuum there is a need to roll forward the existing SPD to provide a consistent approach to heathland matters across the sub region. Rolling forward the SPD places no other obligations on the Council or development industry than has otherwise already been agreed and operated for the last 7 years.

**Options - and reasons for rejection:** Two options are available, either extend the SPD or do not. It is considered that not extending the SPD is not a realistic option for the Council as the 'competent authority' needs to have in place a procedure to mitigate the impacts on the Dorset Heathlands International Sites

**Consultations undertaken:** Extensive public consultation has taken place on the various iterations of the SPD over the last 7 years. The current version was subject to public consultation for 6 weeks prior to reporting back the comments received and adoption by Council in September 2012.

**Finance/Resource Implications:** If no SPD is in place each planning application for residential development would have to be subject to an Appropriate Assessment to ascertain its impact on the heathlands and satisfy the requirements of the Habitats Regulations. This will incur costs on the applicant, including the Council as an applicant, through consultancy fees. The uncertainties, time and cost involved in this process could deter development proposals coming forward and lead to a loss of planning fee income.

Failure to extend the SPD may result in the Council not being able to grant planning permission for any net increase in housing within the Borough.

In this circumstance the Council would be in breach of the Habitat Regulations and could open itself to significant financial costs.


